1. No crafts or food shall be offered for sale. All items presented shall be antiques or high quality collectibles in keeping with the spirit of the show in providing fine quality antiques and collectibles to the public and shall be guaranteed as represented. Show chairperson shall have final approval authority over items offered for sale. All items shall be truthfully represented. All items shall be priced.
2. No smoking shall be permitted in show premises. No improper behavior shall be permitted. Masks may be required due to Niagara county COVID restrictions.
3. No hazardous/ offensive exhibits or conditions shall be permitted.
4. Exhibitors shall be open for business on time and shall not repack until show closes. All exhibitors shall abide by municipal, state, and federal laws including New York Sales Tax laws.
5. The building is locked overnight at 5:00pm after set-up until 7:00am.
6. Exhibitor spaces shall be properly maintained - table shall be covered to the floor, boxes kept under the tables, and aisles shall be kept clear and free of trash, or chairs shall be paid for by exhibitor.
7. No subletting without prior permission. Only one adult helper per individual exhibitor unless prior permission is granted.
8. Neither the Niagara County Central Rotary Club nor The American Legion Post 1452, nor their agents, officers or employee American Legion Post 1452, nor their agents, officers or employees shall be held liable for property damage or loss of personal injury to any exhibitor, its agents, or employees Exhibitor accepts full responsibility and releases Niagara County Central Rotary Club and American Legion Post 1452 and their agents, officers, and employees from all liability and any losses, damage, or injuries which may occur to any Exhibitor, its agents, its employees, or its personal property.
